TOWN COUNCIL MEETING MINUTES AUGUST 11, 2025, 5:30pm

- CALL TO ORDER
- ROLL CALL: Charles Moore, DeeDee Crawford, Sarah Underdue, Rebecca Spengler, Freida Weddington; Mayor Robert Hayes, Presiding
- PLEDGE OF ALLEGIANCE
- Motion to accept the agenda for August 11, 2025 with the alteration of moving Alberta Solar: Decommisioning Agreement to 1st Recognition of Visitors made by Rebecca Spengler; seconded by Freida Weddington, carried.
- Motion to accept the Minutes for July 14, 2025 made by Freida Weddington; seconded by Rebecca Spengler; carried.
- Motion to Approve Billes Received July 14, 2025 August 11, 2025 totalling \$8,125.68 made by Freida Weddington; Seconded by Sarah Underdue; carried.

Recognition of Citizens / Visitors:

O Andy Brownstein, Greenhurlocker, PLC & Tom Holt, Ameresco: Alberta Solar Decommissioning Agreement. In the case of a commissioning, the Agreement would allow for the property owner to receive the bond first and if they do not use it then the Town would get it. Joe Whitby has had time to look over the Agreement and found it to be good but would like to see how they came up with the bond amount. Tom Holt was able to show Joe Whitby the documentation. Joe Whitby was satisfied. Charles Moore questioned why this is coming up at this time. Tom Holt explained that it was the next step in accordance to the Town of Alberta Solar Facilities Article 19. The process was already in place with the Town Councils approval. Today is merely to formally allow the property owner first right to the Bond. Rebecca Spengler made a motion to approve allowing the property owner to be placed first; Seconded by Freida Weddington; carried.

- Pest Control: Asked 4 companies for quotes tor inside and outside town offices and old fire hall; general pest control for park and caboose.

- Tablecloth: Asked many vendors to quote on a 3-sided, fitted tablecloth with TOA Emblem on it. Only Dogwood Graphics submitted a quote. One Tablecloth is 219.76 plus tax. Two tablescloths are \$390.15 plus tax. A motion was made to approve the purchase of two tablescloths for \$390.15 plus tax was made by Sarah Underdue; Seconded by Freida Weddington; carried.
- Mayor Hayes has completed a spreadsheet for maintenance. He will be talking with them on Friday.
- Farmers market doing well. Mayor Hayes went to McKenney market last Friday and to South Hill on Saturday. It seemed to him that South Hill had more arts and crafts than farmers.
- Robert will be meeting with Andy at SSPD on Friday to discuss possible grants for the caboose and a possible skate park.

- o Merchant Services: FCB waiting for clarification from Robert
- OMV STOP. The system will cost us \$65 for 4 years. There will be a processing fee of \$25 when we place a hold and we remove a hold (\$50 total). It was confirmed with Joe Whitby that it is within our legal rights to pass that \$50 fee on to the taxpayer. Beth Crowder has already spoken with Southern Software as to how to manually place the \$50 penalty onto the vehicles. There are 70 Personal Properties Accounts presently in arrears. A Motion was made to pay the \$65 software fee out of Technical Upgrades and apply the \$50/vehicle fine to the taxpayer was made by Rebecca Spengler; Second by Freida Weddington; carried.
